FORGE PROJECT STEWARDS A COLLECTION OF 180 PIECES OF CONTEMPORARY ART WITH AN EMPHASIS ON THE WORK OF LIVING INDIGENOUS ARTISTS. THE COLLECTION IS DISPLAYED ON A ROTATING BASIS ON SITE AND IS AVAILABLE FOR RESEARCH AS WELL AS LOAN FOR OFF-SITE EXHIBITIONS.

FROM THE OUTSET, THE FORGE PROJECT COLLECTION WAS INTENDED AS A WORKING COLLECTION, WITH LOANS TO MUSEUMS, GALLERIES, AND CULTURAL CENTERS TAKING PLACE ALMOST IMMEDIATELY AFTER ITS FOUNDING IN 2021, LOANING TO 20 DIFFERENT INSTITUTIONS WORLDWIDE IN 2024. THE PURPOSE OF THE LENDING PROGRAM IS TO SERVE AS A MODEL FOR MAINSTREAM ART COLLECTIONS AND COLLECTING. AMONG ITS VALUES, THE LENDING PROGRAM ENDEAVORS TO:
